ORDER GRANTING PLAINTIFFS' MOTION FOR ATTORNEY'S FEES AND COSTS

Complaint filed: August 28, 2019

IT IS HEREBY ORDERED THAT Plaintiffs' Motion for Attorney's Fees and Costs is **GRANTED** in its entirety. The Court, having carefully reviewed the record in the case and the evidence submitted by Plaintiffs and Class Counsel, orders as follows:

Plaintiffs are entitled to an award of attorneys' fees under Federal Rules of Civil Procedure Rule 23(h). Plaintiffs' award of \$800,000 in fees and expenses is fair and reasonable in light of the result obtained, the time and labor devoted to the case by Class Counsel, the skill, experience, reputation and ability of Class Counsel, the contingent nature of the fee requested, the hours spent and hourly rate of Class Counsel, a consideration of comparable settlements in other data breach class actions, and the overwhelmingly favorable reaction of the Settlement Class.

Class Counsel has substantiated their fee request with declarations describing their billing practices, billing rates, hours worked, tasks performed and corresponding lodestars for their time invested into this case. The hourly rates, as summarized in the chart below, are reasonable in light of the skill, expertise and reputation of Class Counsel. The Court finds the total number of hours claimed as reasonable.

Based on their fee request for \$800,000, the declarations of Class Counsel documenting their total lodestar shows that a fee award of that amount would result in a multiplier of approximately 1.15. Application of that fee multiplier would be reasonable, as it is well within the range approved in comparable class action cases. In light of the contingent nature of the fee, the risks undertaken by Class Counsel in prosecuting this action, the delay in payment, the quality of Class Counsel's representation, and the results obtained, the Court finds that Class Counsel's fee request is fair and reasonable.

Plaintiffs' request for an award of \$800,000 in fees and expenses is **GRANTED**. **IT IS SO ORDERED.**
